3 WHEREAS, on April 2, 2024, the Court granted preliminary approval of the proposed
4 class action settlement (ECF No. 128) and scheduled the final fairness hearing (the “Settlement
5 Hearing”) for August 30, 2024, at 9:00 a.m. in Courtroom 5 – 2nd Floor of the United States
6 Courthouse, 1301 Clay Street, Oakland, CA 94612 (*id.* at ¶5);


